The Financial bids of only the Shortlisted Applicants will be opened. The least cost of providing catering services for each of the constituted groups will be declared during the opening of the Financial Bid. All the Shortlisted Applicants who agree to match the least cost for providing catering services for each of the constituted groups will be empanelled with the Authority as "Empanelled Agency".</p>	<p>The minimum score for qualifying Technical Evaluation will be 70 and all Applicants with more than or equal to 70 marks will be called the "Shortlisted Applicants". The Financial bids of only the Shortlisted Applicants will be opened. The least cost of providing catering services for each of the constituted groups will be declared during the opening of the Financial Bid. The top 3 highest scoring shortlisted applicants who agree to match the least cost for providing catering services for each of the constituted groups will be empanelled with the Authority as "Empanelled Agency".</p> <p>The empanelled agency with the highest technical score shall have the right to choose their cluster for providing catering services, followed by the second highest technically scoring bidder and so forth. The authority reserves the right to empanel more agencies in order of their technical score and willingness to match the least cost for providing catering services for each of the constituted groups.</p> <p>The empanelment shall be for a period of 1 year.</p>
